Evans Lake hosts six thousand people a year, primarily in our youth programs.

Since 1960, Evans Lake has been providing unique outdoor education opportunities for children and youth in a spectacular camp setting. Our flagship summer camp program provides an unparalleled combination of fun, outdoor adventure and learning opportunities in an immersive experience that brings campers together for spectacular week-long adventure. Outside the summer season, we host schools from around the South Coast and deliver a unique environmental curriculum in the temperate rainforest.

This unique multi-day immersive experience continues to connect with thousands of youth every year, providing an incredibly special opportunity to learn in community. This type of learning environment has a proven ability to boost the development of relationship skills and self-confidence and fosters a life-long affinity for nature.

## **GENERAL**

Through committees our board is able to focus on important tasks with a group of volunteers, dedicated to helping the Society enhance the work and reach of our organization. Committees support our board and leadership team in completing various projects.

# **CURRENT COMMITTEES**

Currently, we have three types of committees- Standing, Special and Advisory. Each committee requires a different commitment level, as noted in parenthesis below.

#### Standing Committee (Board Members Only)

Provide specialized assistance, advice, and recommendations to BOD on **continuing basis**. Standing committees tend to have **more authority and responsibility** to accomplish their work. Board usually takes all advice and recommendations. Our current standing committees are:

- Governance & Development (Quarterly)
- Finance (Monthly, until capital plan developed, then 2x per year)

# Special Committee

Formed to handle **a specific situation/issue** not already covered by another committee. Dissolved once job is done. Board makes decisions based on their advice and recommendations.

- Strategic Plan (Monthly, until plan developed)
- Capital, including Fundraising (Monthly)
- REDI- Reconciliation, Equity, Diversity, and Inclusion (Monthly until plan developed, then Quarterly)
- Financial advisement

#### **Advisory Committee**

This type of committee is struck to **advise on particular issues that require special expertise**. E.g. developing policies, creating a business plan, building a new facility. Often includes non-board members. Board is under no obligation to take the advice or recommendations (though it frequently would).

- Friends of Evans Lake (Semi-annually)
- Alumni (Quarterly)
- Program (Quarterly)

## REPORTING AND EVALUATION

- Each committee will be provided with a terms of reference document that outlines the task, tools and guidelines for accomplishing the goal of the committee
- A committee will have a board member or staff member assigned to participate, or act in an advisory role.
   Committees will report back to the board of directors with their recommendations and for board approval.
